# WELCOME

The three Citrus, Levy and Marion County Workforce offices and the Veteran's Staff invite you to make use of the variety of professional services we provide to veteran job applicants. Florida's One-Stop Career Centers are staffed with a network of professional Disabled Veterans Outreach Program (DVOP) Specialists and Local Veterans Employment Representatives (LVER) staff who are tasked to provide **priority workforce services** to veteran customers. DVOP staff focus on providing intensive case management services to veterans with barriers to employment, disabled veterans, etc. LVERs conduct outreach to employers and engage in advocacy efforts with hiring executives and managers to increase employment opportunities for veterans. LVER staff are also responsible for ensuring that veterans are provided the full range of **priority workforce services** in the One-Stop Career Center, providing functional oversight over the one-stop Veteran's Program and service delivery strategies and services targeting veterans.

The names and phone numbers of your Local Veterans Employment Reps (LVER) and Disabled Veterans Outreach Program Reps (DVOP) are as follows:

## **Priority of Service**

Priority of service extends to DOL funded employment and training programs for veterans meeting programs' eligibility requirements.

## **Veterans**

- \* Veterans (at least 180 days of active duty with other than Dishonorable Discharge)
- \* Certain spouses (service member/veteran died of service-connected disability, MIA, captured or forcibly detained)

Priority of Service is defined as - a veteran shall be given priority over a non-veteran for receipt of employment, training, and placement services in job training programs if the veteran meets the program's eligibility requirements

## **PROOF OF VETERAN STATUS**

The Workforce offices and many other agencies providing services **require** proof of veteran status. If you are claiming veteran preference for Federal, State, County or Municipal positions, the **only** documentation acceptable for this is the DD Form 214, Certificate of Release or Discharge from Active Duty. If you do not have your DD Form 214, copy 4 (member copy), please ask one of the veteran's staff to provide you with a request form SF180, or go on line to this link to order one

## **WHAT THE WORKFORCE OFFICE CAN DO FOR YOU**

### **1. REGISTRATION**

When you initially report to a Workforce office, one of our associates will instruct you on the registration process. You will be asked to enter your employment history, job skills, salary and personal desires into the statewide employment information system.

As local employers list jobs, veteran applicant files are searched to find qualified veterans. If a qualified veteran matches the employer's desired skills, a veteran

representative will make every attempt to contact the veteran. Additionally, a veteran representative is available for job assistance, counseling, and any other veteran related issue.

## 2. **SEARCHING FOR WORK ON THE VIRTUAL JOB LINK**

The Workforce office website, [www.employflorida.com/](http://www.employflorida.com/) gives you career guidance, online job searches, resume and letter-writing assistance; training and education program information, detailed information on specific employers and industries and access to state & national job searches. This site encompasses all areas of job seeking, labor market research, and benefits and social services. Additionally, this site allows a user to search for employment and create a basic resume, it will also allow users to assess their job skills & investigate other career fields.

## 3. **USING WORKFORCE OFFICES CENTER RESOURCES**

All Workforce offices offer Resource Rooms with video and print libraries on many employment topics, computers with a resume maker, scanners, fax machines and a dedicated staff to assist you in using these resources. We also offer a weekly schedule of job skill workshops designed to help you obtain employment. There are also on site job recruitment fairs that are held. Please ask a veterans representative for a list of scheduled workshops or employment recruiting events. These resources are available ***free of charge***

## 8. **VETERAN RE-EMPLOYMENT RIGHTS**

Under the Veterans' RE-EMPLOYMENT Rights (VRR) law, a person who left a civilian job to enter active duty in the Armed Forces, either voluntarily or involuntarily, may be entitled to return to the job after discharge or release from active duty.

Four basic eligibility criteria must be met:

- a. The person must have been employed in an "other than temporary" civilian job.
- b. The person must have left the civilian job for the purpose of entering military service.
- c. The person must not remain on active duty longer than four years, unless the period beyond four years is at the request and for the convenience of the federal government and the military discharge carries this statement.
- d. The person must be discharged or released from active duty under honorable conditions.

If you have questions or need assistance, contact the U.S. Department of Labor's director for Veterans Employment and Training (DVET) for Florida. Your veteran representative can provide contact assistance.

## **TRAINING PROGRAMS**

### 1. **WORKFORCE INVESTMENT ACT (WIA)**

A program administered by the Workforce office which provides training opportunities to economically disadvantaged individuals, those with serious employment barriers or handicaps, and those who qualify under the Economically Disadvantaged Workers Assistance Act (EDWAA). This training can be either classroom or on-the-job training

and is designed to lead to permanent employment. Please contact your local Workforce offices for more information.

## 3. **Spouses to Teachers (STT) program**

Spouses to Teachers (STT) is proudly represented in **California, Colorado, Florida, Georgia, Texas, Virginia, North Carolina, South Carolina, and Louisiana**. The Colorado office services spouses in **Kansas, Nebraska, Nevada, New Mexico, and Utah** as part of the Spouses to Teachers Program. This program is designed to assess the needs of spouses relative to becoming a teacher. The program provides support to eligible spouses in their pursuit of K-12 teaching positions. Limited funding will be provided to eligible spouses to reimburse the cost of tests required for state teacher licensure/certification. Maximum available financial assistance is \$600.00 per person. ## 4. **Vets Retooling and Refueling Program**

This program is sponsored and paid for by the CLM Workforce Connection Board of Directions and is aimed at all Veterans who have been discharged within the last few years. It is a 2 and 1/2 day seminar held at CFCC which provides assessment information for the veteran, resume writing skills, interviewing training, networking and other valuable information that will help a Veteran who is seeking a career and/or direction.

#### **Ten Steps to Getting Hired by Uncle Sam**

Job seekers interested in working for federal government can be turned off by the federal application process, but if you persist, you'll discover some similarities to looking for a job in the private sector.

Follow these 10 steps to make your government job search more manageable – just be sure you know what you may need to do differently to land a job with Uncle Sam

### **Step 1: Network**

Similarities: In both sectors, networking initially can be more about gathering info, contacts and leads than getting hired.

Differences: First-timers may feel stumped when trying to locate federal employees to contact. Ask around and persist. Look in your neighborhood, church, ski club, etc

### **Step 2: Become Familiar with the Hiring Process**

Similarities: Whether you're going private or fed, you'll need to figure out who to work for, relevant job titles, appropriate salaries and where to apply.

Differences: Understanding the hiring process for a federal job requires a little more research on your part, because job postings often seem to be written in each agency's own unique language. You can learn more about federal agencies at FirstGov, as well as about obscure job titles at USAJOBS' Explore Your Career Opportunities page.

### **Step 3: Look for Openings**

Similarities: Today's savvy seekers look to the Internet for the latest job postings.

Differences: Rather than searching numerous company Web sites and job boards, aspiring federal employees have the benefit of one-stop shopping: USAJOBS, a Web site of the US Office of Personnel Management.

### **Step 4: Assess Your Soft Skills**

Similarities: Soft skills are your personal qualities, like being flexible, resourceful, resilient, etc. Determine your soft skills and then play them up to stand out.

Differences: In the public sector, soft skills are called core competencies (CCs). When HR reviews applications, the CCs are heavily weighed in determining who deserves an interview. Agencies occasionally reconsider the CCs they're seeking, and some feature them on their Web sites.

### **Step 5: Analyze Keywords in Announcements**

Similarities: To strengthen your resume, it's wise to scrutinize listings for the language of the job as well as required skills.

Differences: Keywords tend to be in the Duties, Qualifications and KSA (Knowledge, Skills and Abilities) sections of federal announcements. Sixty percent of federal announcements call for electronic resumes, and more will soon. E-resumes, scored by computer, make including keywords essential.

### **Step 6: Create Your Resume**

Similarities: Time invested in constructing a strong resume is a good investment.

Differences: Federal resumes demand more detail and run three to four pages. The feds often ask you to include social security numbers, addresses and phone numbers of supervisors from the past 10 years. Look for specific

### **Step 7: Write Your KSAs and Cover Letter**

Similarities: Identifying your hard skills, those you've developed at work or school, is a vital part of job searching. You should highlight these skills in cover letters and during interviews.

Differences: When applying for federal jobs, you need to submit KSA statements along with your resume and cover letter. KSAs are all about hard skills.

### **Step 8: Apply for Jobs**

Similarities: Finding an actual job you want to go for can be both exhilarating and nerve-racking.

Differences: Application processes vary in surprising ways from agency to agency. This is where some frustrated first-timers drop out. Stay sane by reading the vacancy announcements very carefully.

### **Step 9: Follow Up on Your Application**

Similarities: Phoning in to check on your application's status can strengthen your position in the game.

Differences: Follow-up is even more critical in government. One reason is that announcements are sometimes dumped and reissued. If you don't call, you'd never know to reapply. Leave a strong voice-mail message 30 days after submitting your application package.

### **Step 10: Interview for the Job**

Similarities: In both worlds, success occurs when strong preparation and opportunity meet. So prepare well.

Differences: In the federal market, an invitation for an interview usually appears in writing, via a letter or email. Your interview could be in person, before a panel or over the phone. Situational interviews (i.e., how would you handle this?) are popular.

## **5. Electrical Apprenticeship Program**

A four year program designed so that a participant may become a trained, licensed, journeyman electrician. It is divided into two major parts:

1. A paid, on-the-job training with a local electric company, where the student gains practical knowledge of the trade. The on-the-job work experience is a typical 40-hour work week at an entry level wage.
2. Classroom instruction, where the student learns the technical aspects of the trade. The classroom instruction is held two evenings per week at the community education building, from 6:00 pm to 9:00 pm.

**ENROLLMENT IS LIMITED.  
ENTRANCE REQUIREMENTS INCLUDE:**

1. A regular high school diploma or GED
2. A valid Florida drivers license
3. At least 18 years of age
4. A resume of work experience
5. Hired and sponsored by FAEC employer
6. Availability of space in the program
7. Meets the basic skills requirement of the 9<sup>th</sup> grade level on Form A of the TABE tests in math, reading, and language.
8. Applicant required to be drug free

The goal of the Vet Center Program is to provide a broad range of counseling, outreach, and referral services to eligible veterans in order to help them make a satisfying post-war readjustment to civilian life.

Parents, spouses and children of armed forces personnel who died in the service of their country and family members of Reservists & National Guardsmen who died while on duty are offered bereavement counseling at the Vet Center.

**Vet Center Services are free to eligible veterans and families.**

Post Traumatic Stress is a set of reactions to a trauma such as war, which can be experienced by almost anyone. With the passage of time, when feelings or issues related to the trauma are not dealt with but are suppressed by the individual it sometimes becomes a disorder (PTSD). This can result in problems of readjusting to community life. A delayed stress reaction may surface after many years.

### **3. VOCATIONAL REHABILITATION COUNSELING**

Voc Rehab seeks to determine whether a veteran's disability causes a serious employment handicap and whether a vocational goal is feasible for the veteran. To be eligible for Department of Veteran Affairs (VA) Vocational Rehab (Chapter 31), the veteran must have a service-connected disability, which materially contributes to an employment handicap.

To be eligible for State of Florida Vocational Rehab, an individual must have a disability that is functionally limiting in terms of employment. If you feel you have a disability, which is a barrier to employment, please see a veteran representative for further assistance or contact VR&E by visiting their website.

#### **Eastbound on I-4**

Take exit 84 (old exit 42), Lake Ivanhoe, get immediately in the left lane and make a left onto Legion Place (before going under I-4). Get in right-hand lane and make a right at the first light, Garland Avenue, and then make first right into the parking lot.

#### **Westbound on I-4**

Take exit 84 (old exit 42) to lake Ivanhoe, bear right and go under I-4, which will put you on Legion Place. Stay in right lane and make a right at the first light onto Garland Avenue, and then make first right into the parking lot.

## **VETERANS IN FEDERAL EMPLOYMENT**

*(All veterans are advised to visit/call their local veteran's representative regarding preference.)*

### **1. VETERANS PREFERENCE in FEDERAL EMPLOYMENT**

a. **5 Point Preference:** Given to honorably discharged veterans who serviced on active duty in the Armed Forces of the United States:

\*During World War II (Dec 7, 1941 - Apr 28, 1952)

\*During the Korean Conflict (April 28, 1952-July 1, 1955)

\*In a campaign or expedition for which campaign badge has been authorized, and, if the person enlisted after Sep 8, 1980, served continuously for 24 months.

*(Individuals who have incurred a disability in the line of duty which the Department of Veterans Affairs determines is compensable are excluded from this 24 month service requirement).*

\*For more than 180 consecutive days, any part of which occurred after Jan 31, 1955 and before October 15, 1976. (An initial period of active duty for training under the "six month" Reserve or National Guard programs does not count.)

**Note:** Under PL 95-454, Oct 13, 1978 (Civil Service Reform Act), retired members of the Armed Forces are no longer considered preference eligible as of Oct 1, 1980, unless they are disabled veterans or retired below the rank of Major or the equivalent.

b. **Ten Point Preference:** Given to:

\***Disabled Veterans** - an honorably separated veteran who served on active duty in the Armed Forces at any time, and who:

(1) Has a service-connected disability, or

(2) Is receiving compensation, disability retirement benefits, or pension under laws administered by the U.S. Department of Veterans Affairs, Army, Navy, Air Force, Coast Guard or Marine Corps. A veteran who has been awarded the Purple Heart for wounds received in action is considered to have a service-connected disability.

\***Wives or Husbands, Widows or Widower and Mothers of Veterans** - You may be eligible for a 10-point veteran preference. Please see a veteran's representative for further guidance.

### **2. VETERANS READJUSTMENT APPOINTMENTS (VRA)**

The VRA is a special authority by which agencies can, if they wish, appoint an eligible veteran without competition. The candidate does not have to be on a list of eligible's, but must meet the basic qualification requirements for the position. The VRA is a convenient method of appointment for both the agency and the veteran. However, use of the authority is entirely discretionary and no one is entitled to a VRA appointment. VRA appointees initially are hired for a 2-year period. Successful completion of the 2-year VRA appointment leads to a permanent civil service appointment.

a. **Service Requirements:**

You must have served on active duty for a period of more than 180 days which occurred after August 4, 1964, and received other than a dishonorable discharge. Active duty is full-time duty in the Armed Forces, other than active duty for training. You do not need to serve more than 180 days of active duty, if you were discharged or released from active duty because of a service-connected disability.

b. **Time Limit:**

Eligible post-Vietnam era veterans qualify for 10 years after the date of your last discharge or release from active duty or until December 31, 1999, whichever is later. Eligible Vietnam era veterans (those who served on active duty between August 5, 1964, and May 7, 1975) qualify until 10 years after your last discharge or separation from active duty or until December 31, 1995, whichever is later. Eligible veterans with a service-connected disability of 30% or more have no time limit. If you are selected for a VRA and have less than 15 years of education, you must agree to participate in a training or educational program.

c. **Grade Levels of Jobs That Can Be Filled:**

Agencies can use the VRA authority to fill white-collar positions up through GS-11 and equivalent jobs under other pay systems. Veteran's Readjustment Appointments are in the excepted service. After two years of substantially continuous service under a Veterans Readjustment Appointment, providing your performance has been satisfactory, your appointment shall be converted to the competitive service.

d. **How to Apply:**

You should contact the Federal agency personnel office where you are interested in working to find out about VRA opportunities. Agencies recruit candidates and make VRA appointments directly.

**3. NONCOMPETITIVE APPOINTMENTS for 30% or MORE DISABLED VETERANS**

Veterans who have a service-connected disability of 30% or more may apply directly to Federal agencies for consideration for noncompetitive temporary appointments. 30%-disabled veterans on a temporary appointment may be converted non-competitively to a career or career-conditional appointment.

**4. VETERANS REOPEN ELIGIBILITY**

Under certain conditions, veterans can file an application for Federal positions, which are not on the Federal Job Opportunity List and are not open to the acceptance of applications from the public. To be eligible for this eligibility, you must meet one of the following conditions:

- a. Have been awarded the Purple Heart
- b. Have a service-connected disability

- c. Be receiving compensation, disability retirement benefits, or pension because of a public statute administered by the Veterans Administration or a military department.
- d. Be entitled to ten point veteran's preference as a widow, widower, spouse or mother of a veteran 100% disabled or rated as unemployable.
- e. Will be discharged from active duty in the armed forces within 120 days or if you have been discharged from active duty in the armed forces, apply within 120 days of discharge.

**If you meet one of these conditions and wish to apply for a position, please see your veteran representative.**

**5. CIVIL SERVICE PREFERENCE CERTIFICATES**

The Department of Veterans Affairs will issue civil service preference certificates to eligible veterans seeking Government employment. You must have received an honorable discharge or have incurred a service-connected disability during any period of service. Normally, your months of entitlement under the Post-9/11 GI Bill will be equal to the number of months of entitlement you have remaining under the MGIB-AD. However, if you use all of your MGIB-AD benefits, then you may be entitled to a maximum of 12 additional months of benefits under the Post-9/11 GI Bill.

#### **For individuals eligible for MGIB-SR and/or REAP**

Normally, individuals who are eligible for more than one benefit may use a maximum combined total of 48 months of benefits.

**VOCATIONAL REHAB:** For disabled vets who apply within 12 years of the date your disability was assigned by the VA, the VA will pay tuition and fees, and the cost of books, tools and other program expenses as well as provide a monthly living allowance. **DENTAL TREATMENT:** VA provides necessary dental care for veterans who were not provided dental examination and treatment within 180 days of discharge or separation from service. The time limit does not apply to veterans with dental disabilities resulting from combat wounds or service injuries.

2. **SOME VA BENEFIT SUBJECTS NOT COVERED:**

Pension, Disabled Veterans Property Tax Exemption, Specially Adapted Homes, Automobiles, Clothing Allowances, Veterans Rated Unemployable, Veterans Mortgage Life Insurance, Dependency and Indemnity Compensation (DIC), Burial Benefits, Nursing Home Care, Domiciliary Care, Board of Veterans Appeals, Military Medals, Review of Discharges. If you need to know about these, contact your veteran's representative. Or call this toll free number: 800-827-1000

3. **VA WORK STUDY PROGRAM:**

Veterans receiving VA educational benefits and enrolled at least 3/4 time in a college degree, vocational rehabilitation or professional program may "earn while they learn" under this program. Services performed under the VA Work-Study Program must be veteran related in nature. See a veteran representative for further information

4. **NATIONAL PARK SERVICE GOLDEN ACCESS PASSPORTS:**

This is a free lifetime entrance pass for persons who are blind or permanently disabled. It is available to citizens or permanent residents of the United States, regardless of age, who have been determined to be blind or permanently disabled. You may obtain a Golden Access Passport at any entrance fee area by showing proof of medical determined disability and eligibility for receiving benefits under federal law.

The Golden Access Passport admits the pass holder and any accompanying passengers in a private vehicle. Where entry is not by private vehicle, the passport admits the pass holder, spouse, children, and parents. The Golden Access Passport also provides a 50% discount on federal use fees charged for facilities and services such as fees for camping, swimming, parking, boat launching, or cave tours. It does not cover or reduce special recreation permit fees or fees charged by concessionaires. To apply for your Golden Access Passport, take a copy of your VA disability letter to any National Park Service entrance fee area.

5. **GUIDELINES FOR FILING CLAIMS WITH THE DEPARTMENT OF VA:**

a. Get a State or County Veterans Service Officer (listed in 6, below) or a veteran's service organization to help you fill out your claim. The veteran's service organizations "Service Officers" can be found by calling the Department of Veterans Affairs Regional Office where they often locate their operations offices or by calling the veterans group itself (see Veteran Service Organizations listing).

b. Do not let anyone charge you for helping fill out your claim. Legally, you cannot pay anyone to represent you in a VA claim matter until you have indicated to the VA regional office in writing that you disagree with its decision and have had your claim rejected by the Board of Veterans' Appeals.

c. Ask for benefits as soon as possible - even if you do not have a formal claim form. A dated, handwritten note is enough to start your claim, and it will establish the earliest date for which the VA will pay benefits if your claim is later approved. The formal application form, VA Form 21-526, should be filed within one year of when the Department of Veterans Affairs sends it to you.

d. Good evidence is the key to winning a claim. Provide your advocate with all medical records, military records and statements from relatives or friends that support your claim.

e. Be consistent and clear in what you tell the VA about your medical condition. Inconsistencies in veterans' statements can be used against them when the VA raters decide whether to approve a claim.

f. Remember that the VA's examining doctors who evaluate your condition in with your claim are not paid to be on your side. They are more like insurance company doctors; their job is to help the VA regional office decide whether you are entitled to benefits. **Be honest, but think first about what you say to the VA doctor.**

g. You can appeal the decision by officials in the regional office to the Board of Veterans Appeals: If they find your illness is not linked to your military service; if the illness is rated as less severe than you think is fair; if you disagree with the date when the VA says it will begin disability payments. If you disagree with the VA's decision, you should promptly file a notice of disagreement with the VA regional office.

6. **COUNTY VETERAN SERVICE OFFICERS (VSO):**

Inform veterans and their dependents of benefits to which they are entitled and assist them in obtaining benefits by filing claims and supporting documents which will justify their claims.

# e-VETS Now On Line

## **Internet Portal Links to Veterans' Services Web Sites**

Active duty military personnel, veterans, reservists, National Guard members, and their families are now just one click away from hundreds of web sites containing information about programs and services available to them, thanks to a new Internet gateway developed by the U.S. Department of Labor.

Known as the e-VETS Resource Advisor, users can choose from categories such as job search skills and tools, employment listings, career assessment tools, entrepreneurship, federal employment, education and training providers, Department of Veterans Affairs (VA) benefits, State veterans benefits, military records, veterans service organizations, housing, and financial assistance.

e-VETS allows users to customize their selections by selecting personal categories including whether they are a disabled or military conflict veteran, their branch of service, their sex and/or age, and if they have any barriers to employment. This information allows e-VETS to produce a list of Web site links of specific interest to an individual user.

Vietnam veterans (plus veterans who served in Korea in 1968 or 1969), and other veterans who may have been exposed to Agent Orange or other herbicides elsewhere during the testing, transporting or spraying of herbicides for military purposes and who are concerned about possible long-term health effects of Agent Orange exposure – contact the nearest VA medical center and request an Agent Orange Registry health examination. More than 300,000 Vietnam veterans have already participated in this program.

Vietnam veterans who need medical treatment for conditions that may be related to their exposure to Agent Orange or other herbicides used in Vietnam – contact the nearest VA medical center for eligibility information and possible medical treatment.

Vietnam veterans with illnesses that they believe were incurred or aggravated by exposure to Agent Orange or other aspects of military service – contact a VA veterans service representative at the nearest VA regional office or health care facility and apply for disability compensation. The counselors have information about the wide range of benefit programs administered by VA. The national toll-free number is 1-800-827-1000.

Vietnam veterans who encounter difficulties at a VA medical center – contact the “patient advocate” at that facility for assistance in resolving the problem. Ask the medical center telephone operator for the patient advocate or representative.

Vietnam veterans with children who have spinal bifida – contact the VA national toll-free hotline at 1-800-820-1756 or the nearest VA regional office by calling toll-free: 1-800-827-1000. Additional information on spinal bifida is available from the Spinal Bifida Association of America at 4590 Mac Arthur Blvd., Suite 250, Washington, DC 20007-4226; toll free telephone: 800-621-3141;

To apply for VA reimbursement of health care costs, call 1-800-733-8387.

Do not be discouraged by someone from the VA who tells you not to apply. INSIST on submitting a claim in WRITING! The sooner you apply, the sooner the monthly compensation and health care cost reimbursement can begin.

After you apply, the VA should send you a form to fill out and return. Along with this form, it may be helpful to send VA copies of the veteran’s DD214, the child’s birth certificate, and medical records showing the child has spinal bifida.

As with any VA claim, it is best to get representation from a knowledgeable veterans service officer, either through a veterans organization or a state or county veterans agency. As with all things, take part in this process; and ask questions if you don’t understand. Make copies of EVERYTHING you mail/submit/whatever for your file and protection.

## **Employment Protection for Reservists, National Guard Members and Veterans**

The Uniformed Services Employment and Reemployment Rights Act (USERRA) of 1994 provides employment/reemployment protection for Reservists, National Guard Members, as well as some recently separated veterans returning to their previous civilian jobs. The USERRA Law includes the following benefits:

- National Guard and Reserve members are entitled to a leave of absence from their civilian private and public sector employers for the period necessary to perform military service, whether that service is voluntary or involuntary. They are not required to use their earned personal vacation during the period of service;
- Employees are entitled to restoration in employment following military service, with seniority, status, and rate of pay as if continuously employed;
- Persons are not to be discriminated against in hiring, retention in employment, promotions, or other benefits of employment because of past or present military affiliation or obligations, or because of an intent to join the military, whether it be Active, Reserve or National Guard; and
- Non-career active duty military members are entitled to reemployment rights with their previous civilian employers.

The Disabled Veterans' Outreach Program (DVOP) Specialists, Local Veterans' Employment Representatives (LVER), Business Marketing Representatives assigned to the Workforce offices will also serve as marketing conduits for the provision of USERRA information. LVER/DVOP staff and other associates will not attempt to resolve a USERRA dispute between an employer and a reserve force member or veteran, as this is the responsibility of VETS. Interested Reservists, National Guard members and veterans and their families will also be exposed to the complete menu of services available via the DOL VETS Representatives, contact your local DVOP or LVER for information.
